Regarding proof of contribution level recognition:

1. The total number of participants (including scholars and audience members) must exceed 70 people. Number of people are based on a daily basis. Same participant on the same day is considered only once.
2. \*Corresponding courses, workshops, or practical activities shall be organized in conjunction with the forum, and be held in the same year (or within one year before/after the event).
3. Theme of the academic forum should have interdisciplinary characteristics, or address important issues in a specific academic field.
4. Keynote speakers or panelists for the academic forum should embody a blend of local, international, and cross-generational attributes.
5. Singular recognition shall be accorded to a primary organizer if there is more than one organizer for the forum. If there are more than two co-organizers (jointly organized, co-organized), recognition shall be limited to two co-organizers.
6. 5 points for forum primary organizers. 2 points for forum co-organizers
